2 application for Site Certification to the Washington State Energy Facility
3 Site Evaluation Council (EFSEC) to construct and operate the Desert Claim
4 Wind Power Project.

6 **II. STATEMENT OF GENERAL ISSUES**

8 Pursuant to EFSEC Notice of Intent to Hold Adjudicative Proceeding, CTED identifies
9 the following preliminary issue:

10 CTED supports the Desert Claim Wind Power, LLC's Application for Site Certification
11 Agreement, Application No. 2006-02 (revised), as consistent with state energy policy
12 that is to encourage renewable energy resources according to the state energy strategy
13 and RCW 43.21F.015 (1). CTED support is subject to completion of the EFSEC
14 process that includes a satisfactory resolution of permitting issues.
