RESPONSE TO INTERVENORS'  
POSITION ON ALLOCATION OF  
TIME

8 On March 17, 2016, Intervenors Columbia Riverkeeper *et al.*, Columbia Waterfront  
9 LLC, City of Vancouver, City of Washougal, City of Spokane, Columbia Inter-Tribal Fish  
10 Commission, Confederated Tribes of the Umatilla Indian Reservation, Confederated Tribes  
11 and Bands of the Yakama Nation, and Clark County (collectively "Intervenors") filed a  
12 "Position on Allocation of Adjudication Time." Applicant Tesoro-Savage Petroleum  
13 Terminal, LLC d/b/a Vancouver Energy ("Applicant") and the Port of Vancouver ("Port")  
14 concur with Intervenors' position on allocation of time for the Adjudicative Hearing.

15 Applicant and the Port appreciate Judge Noble's efforts to allocate time between  
16 parties to ensure that all issues, witnesses, and exhibits can be addressed effectively.  
17 Intervenors' proposed allocation of time evenly between Intervenors and project proponents  
18 (Applicant and Port) (with one day's time reserved for the Council for the Environment)  
19 achieves this goal, especially in light of the fact that project proponents listed approximately  
20 one-half of the total number of witnesses proposed in the preliminary lists filed by the parties,  
21 as well as over 120 exhibits.

22 Applicant and the Port agree with Intervenors that their proposed allocation of time  
23 and coordinated effort will allow the adjudication to proceed in the most efficient way.
