I am a resident of Washington and am writing in support of the Tesoro Savage Vancouver Energy Distribution Terminal. This crude oil will be refined in US refineries to help meet the everyday needs of residents and businesses along the US West Coast – including those of the state of Washington. The scope of review under the State Environmental Policy Act (SEPA) must include the following:

What is the purpose of the project? The purpose statement must not be narrowly worded to only include the construction of an oil terminal for distribution of oil through the region. The purpose should be broad enough to include providing for the energy needs of the region and providing opportunities for appropriate waterfront development in Vancouver that benefits the local community.

Is there a need for this project? There is not. This proposal, in conjunction with other existing and pending oil terminals, would result in a glut of oil in the Northwest that would far exceed current consumption. There are alternative waterfront development opportunities that would create jobs and generate greater benefits for the local community.

Not only our communities can be divided and emergency services blocked by long trains, but the trains actually are in the habit of exploding and killing people.

Burning these oils increases the overwhelming threat of climate change. The International Panel on Climate Change indicates that the problem is urgent -- now, The earth can quickly reach inhospitable conditions that mankind won't have the knowledge or energy to reverse.

Transporting oil to foreign markets increases climate change by making oil more affordable elsewhere and by increasing prices and revenues for the corporations which leads to more drilling. "On [last] Wednesday, executives for TransCanada and Cenovus warned that if Canada doesn't build the pipelines to transport its tar sands **now**, it could lose the opportunity to do so - meaning that decisions on projects like Keystone XL and the Northern Gateway pipeline could be key to Canada's tar sands development." This concept applies to rail transport and other areas of oil exploitation as well: these unconventional oil supplies can easily become uneconomical to develop as market factors change and there is a narrow window in which it is economical to develop them. By facilitating the transport of this oil -- despite the hazards, dangers and costs it prevents to our local communities -- climate change is increased further hurting mankind.

Since there is no planned upgrade of infrastructure for railways used in this commercial endeavor by the companies involved, it seems that a transport increase by 30,000% of this material (knowing what we do now) through the Port of Vancouver is tantamount to criminal behavior by our elected and appointed county officials and would be open to a class action suit of epic proportions in which the decision making and vetting processes would be subject to minute examination.
