Greater Spokane Incorporated supports the Tesoro Savage Vancouver Energy Distribution Terminal. The proposed project will receive and ship North American crude oil to US refineries to offset or replace foreign imports and declining production in Alaska and California.

To prepare for the recent decline in crude oil in the Alaskan Northern Slope, it is critical to seek alternative domestic crude oil sources to alleviate dependence on foreign imports. It is vital to remember that crude oil is refined to produce the products necessary for businesses to remain competitive in the global market, and is needed to provide the conveniences that have allowed the U.S. to be world leader.

Eastern Washington is a large exporter of agricultural products, with \$412 million in domestic exports, and over \$3 billion in international exports. The region is the largest exporter of cattle, wheat, barley, potatoes, apples, peas, and lentils. It is worrisome that someday, we may have to conduct an Environmental Impact Study (EIS) for every commodity shipped within Washington State. As such, we ask the scope of the (EIS) be site-specific, and be limited to those potential impacts directly related to the facility design and operation of the proposed location of the Tesoro Savage Vancouver Energy Distribution Terminal.

We are concerned that EIS research beyond the site-based facility is an overreach that may dilute the core focus of this facility, and as mentioned above could damper the transportation of other commodities, such as agricultural products, which are vital to the economies of Spokane County, Vancouver, Clark County, and Washington State.
