#### Requests to Amend the BP Cherry Point Cogeneration Power Project Site Certification Agreement

On January 31, 2008, and February 6, 2008 BP requested the Energy Facility Site Evaluation Council (EFSEC) to approve amendments, to the BP Cherry Point Cogeneration Power Project Site Certification Agreement (SCA). If approved, the amendments would allow:

- Transfer of the SCA and associated permits to Cherry Point Cogeneration LLC, a newly formed affiliate of BP p.l.c.
- Remove laydown areas 1 and 3 and associated stormwater treatment facilities from the SCA, as they will no longer be used for the Cogeneration project.
- Modify wetland mitigation provisions to reflect changes in the wetland mitigation plan, to compensate for some additional impacts associated at the Cogeneration site.
- Allow BP to fund a project that would reduce water use at the nearby Intalco Aluminum Smelter and make the unused water available for use by the Cogeneration project, rather than requiring BP to fund the BP-Intalco water reuse project contemplated at the time the SCA was issued.

Starting at 2:00 p.m., EFSEC will conduct an Informational Hearing at 905 Plum Street SE, Conference Room 301 Olympia, Washington. The purpose of the hearing is to receive public comments on the requests to amend the SCA from interested persons or organizations.

Written comments will also be accepted.
