APPLICANT'S MOTION TO CONTINUE
HEARING DATE

This is a motion made by the Applicant herein to continue the commencement of the adjudicative hearing date presently set to commence on August 16, 2004, in the above entitled matter. This motion is based on the files and records herein, and specifically the Applicant's Response to Intervenor ROKT Motion To Stay Adjudicative Hearing Until Issuance of Final Environmental Impact Statement (FEIS) and Applicant's Response to Kittitas County's Prehearing Motions.

Specifically the Applicant requests that EFSEC make some adjustment to the hearing schedule to allow responses to the alternative sites analysis being prepared by EFSEC. All parties should be entitled to submit evidence with respect to EFSEC's alternatives analysis. To provide this, the Applicant suggests that the parties be allowed to submit further prefiled testimony and exhibits *limited only to EFSEC's alternative sites analysis*. No new testimony regarding other matters should be allowed or accepted, in that all pre-filed direct and rebuttal testimony on all other matters has been completed, in accordance with Prehearing Order No. 8.


1 The Applicant suggests simultaneous submittal of prefiled testimony and exhibits on


