I want to speak as someone who has had a business in downtown Vancouver for 25 years, someone who has, with her husband, raised her children here, now adults with children of their own who also live here and are involved in the community. I love this community. I have spent the last three years involved in our Downtown Association, on their board as treasurer. I need to make it clear that I am speaking with my own voice as our board as not yet taken a stand on this oil terminal.

I joined the Downtown Association because I loved their mission statement – their goal is to make Vancouver a place where people want to live, work and visit. We have accomplished much as a community, even through the recession. Esther Short Park and the City of Vancouver have just recently made news because of their great contribution to the quality of our life. We look forward to the expansion of the living areas and the Waterfront Development and hope to see Vancouver grow and prosper and become a wonderful place to be.

How can any of this last if our city becomes known as the largest oil exporter in the Pacific Northwest? Unlike other towns that have oil terminals or refineries, our Port is so close to our downtown. The EFSEC hearing in Vancouver at the end of October was amazing.
