This includes evaluating emergency response capabilities in Vancouver, where oil trains would deliver and store oil, and other communities along the rail and shipping route.
- The increased risk of an oil tanker spill on Washington State waters and along the shipping route.
- The project's impact on climate change. This analysis should include climate change impacts from crude oil as well as tar sands oil from cradle to grave.

After carefully considering the safety, environmental, and climate risks associated with the project, I respectfully ask you to deny Tesoro Savage's application.

Gov. Inslee and EFSEC officials:

I strongly urge you to REJECT Tesoro's proposal (referenced above) because of Tesoro's known corruption, its bad safety record, the pollution caused by transport per se, and the lethal effects that oil transport will have on public health, climate, and environment in the event of an inevitable accident. Remember the explosion at Tesoro's Anacortes refinery in 2010 that killed 7 people?

Tesoro spilled over 800,000 gallons of fracked Bakken Shale oil in North Dakota – the biggest such spill in our history – and then hired dishonest Will O'Brien's to oversee the cleanup. O'Brien's was earlier hired to clean the Exxon Valdez spill, BP's Gulf of Mexico ecocide, Enbridge's massive tar sands pipeline spill in Michigan, and the 210,000-gallon oil spill in April. NONE of these cleanups have been accomplished. – O'Brien's is also contracted to develop an emergency response plan for TransCanada's Keystone XL tar sands pipeline; the entire doings with this project have been fraught with corruption, bribery, intimidation, etc. – O'Brien's also maintains TesoroAlert.com, which gives "crisis communication management" updates. This website is powered by the PIER System, owned by O'Brien's. Corrupt Tesoro does business with corrupt corporations; you can't trust it.

Tesoro wants to transport ca. 360,000 barrels of oil per day through Vancouver, downtown Spokane, the Columbia River Gorge National Scenic Area, the Columbia River per se, and cities and towns along the Burlington Northern Santa Fe line. That's at least 4 mile-and-a-half-long trains per day and 365 oil tankers per year, generating enormous pollution even IF (unlikely) they don't have an accident. Tesoro says this will create jobs. Earlier barge and railroad car accidents have been disastrous and even lethal. I urge you: Do not sacrifice the safety of the entire Northwest for the sake of a few jobs (go to safe, clean, renewable energy instead and provide many jobs).

EFSEC has not yet thoroughly assessed, for land, water, and communities in Washington and the Northwest, the effects of additional train traffic along the route; of train or barge spills; Vancouver's emergency response capability; and the effects on climate change from spills of crude oil or tar sands oil, crude or diluted. The assessments should include potential long-term effects on public health and the climate.

Again, I strongly urge you to thoroughly consider the risks of Tesoro's proposed project. Honest considerations should result in DENIAL of Tesoro Savage's application.
