The Board of the Douglas County Global Warming Coalition of Douglas County, Oregon strongly opposes the proposed Tesoro-Savage oil terminal in Vancouver, Washington. In light of the recent meeting of the governors of the Pacific Northwest which resolved to address the climate crisis, the export of oil from this port represents a dangerous and significant retreat from this commitment.

The recently released report of the International Panel on Climate Change underscores the urgency of addressing global warming and the necessity of keeping fossil fuels in the ground. The report concluded that it is 95%-100% certain that human caused global warming is occurring. What is particularly significant is their warning that in order to keep the planet livable, we must leave 2/3 of the remaining fossil fuels untouched. At the present rate of fossil fuel use, we will reach this amount in roughly 25 years. We cannot, on the one hand, point with pride at our nation-wide carbon reduction and then undermine these efforts by exporting this pollution overseas.

We would also ask that all environmental impacts from the mining and excavation of the oil in Bakken and the tar sands of Canada be considered before reaching a final decision on the proposed oil terminal.

I urge you to assess the full impact of Tesoro Savage's proposal to ship 360,000 barrels of oil each day through Spokane, the Columbia River Gorge National Scenic Area, Vancouver and the Columbia River. Oil-by-rail and export by ship is a bad deal for Washington State and the entire Northwest region. The project comes at a steep price for rail and river communities throughout the state and along the Columbia River, yet offers few jobs in return. Based on the far reaching impacts of this project, I urge you to deny Tesoro Savage's unprecedented proposal.

The public safety and environmental impacts of the state's largest pipeline-on-wheels proposal deserve close scrutiny. For example, EFSEC must assess:

•The potential impacts of a large train-related oil spill along the rail route in Washington and beyond.

•The transportation and public health impacts of additional unit train traffic through communities along the proposed oil-by-rail route. This includes evaluating emergency response capabilities in Vancouver, where oil trains would deliver and store oil, and other communities along the rail and shipping route.

•The increased risk of an oil tanker spill on Washington State waters and along the shipping route.

• The project's impact on climate change. This analysis should include climate change impacts from crude oil as well as tar sands oil from cradle to grave.

After carefully considering the safety, environmental, and climate risks associated with the project, I respectfully ask you to deny Tesoro Savage's application.

These are comments regarding the above referenced project. I have concerns about anticipated train noise that do not appear to be addressed within the Tesoro Savage application.			

Noise generated by train mechanics is mentioned in the project application in Section 4.1.1.2 – Environmental Noise Impacts. Table 4.1-5 – Summary of Major Facility Noise Sources, includes train locomotives and train cars (both at 10 mph), but does not include train horn noise. Train horn noise may potentially have a greater noise impact on humans than noise generated by locomotives and train cars.

Per application Section 4.3.3.2 – Rail, it states that "Most trains will arrive from the east on the BNSF Pasco to Vancouver line, entering Washington near Spokane." This means that all trains arriving at the site from this direction will pass through downtown Vancouver, Washington, the city immediately adjacent to and East of the Port of Vancouver where the facility is proposed.

Thousands of City of Vancouver residents, including myself, call the downtown Vancouver area home. I personally live approximately 1,100 north of the rail line (BNSF tracks) that will carry most of the trains carrying crude oil to the project site. Train horn noise from my residence is loud and unpleasant. Most people who move to downtown Vancouver, a dense urban area, recognize that they are moving into an area affected by transportation noise, including trains, airplanes, trucks, cars and sirens, etc. While I made the decision to move into a neighborhood affected by existing noise, I feel that the impacts of additional, unwanted noise may justify review and potential mitigation.

The City of Vancouver government is in the process of trying to eliminate train horn noise in the downtown area for the benefit of existing and future residents, as well as for improving prospects for

desirable economic development. The Vancouver waterfront area immediately adjacent to the BNSF tracks is planned (and approved) for upscale urbanized commercial and residential development, and the elimination of train horn noise can only help attract new residents and commercial businesses. The City has eventual plans to assist in the upgrading of three downtown BNSF track / roadway crossings where trains current sound their horns, with crossing equipment that eliminates the need for trains to sound horns. However, the City does not have the funding for crossing improvements. Information regarding the City's program and the three crossings can be viewed at the following website:

The addition of the proposed Tesoro Savage trains crossing at the downtown Vancouver crossings, and the associated sounding of horns, is an environmental noise detriment that should be reviewed during the siting approval process, and appropriate mitigation should be required. Mitigation could be in the form of crossing improvement to eliminate the sounding of train horns, or appropriate assessment of funding to be put towards future crossing improvements. Please include the negative impacts of train horn noise when considering this application.

I live in North Bonneville, Washington, with the Burlington Northern tracks passing about 1/4 mi. from my home. I saw the oil cars going by just today. I hear the heavy coal trains - not only their laboring engines, but my house shakes when they go by. They are an endangerment of communities near railways. Do not drag it on for years. The BN tracks go very close to homes in many areas. Don't let tragedies occur by delaying action on railway safety and pollution concerns. As you well know, the coal power plant at Boardman has been polluting and making people sick in the Gorge for decades. Now the oil corps want to add to that by using Burlington Northern trains to fling coal dust and possibly endangering us with oil spills and holocausts.

Here are some concerns and facts I have as a resident of Washington living 1/4 mile from the railroad tracks of Burlington Northern. These have not been listed in the cover letter and I feel they need to be considered by you in the EIS SCOPING of Tesoro Savage transporting oil through the Columbia Gorge:

-- Old and outdated tank cars (e.g. the DOT-111 that carries crude oil and tar sands) should be removed from the rails immediately. A ban starting now on the use of DOT-111 cars, and other inferior cars, is needed rather than a lengthy phase-out process that continues to leave communities at risk.

- Emergency responders, local governments, and the public deserve to know when we are being put at risk. Include in these revisions a notification requirement to all rail communities that are likely to see major increases in crude transport because of the many new proposed terminals around the United States.

- Establish sensible speed limits for all trains carrying flammable or explosive materials. This is especially important for DOT-111s so long as they remain in use since DOT-111s puncture even at slow speed accidents.

- Rail cars carrying volatile materials should not transit population centers during peak times for train/automobile interactions or when potentially impacted parties (schools, churches, concert venues) are likely to host large numbers of people within a potential blast zone.

- Require at least two operators: trains aren't safe when operated by just one tired engineer. Trains should have adequate, sleeping facilities for engineers, an alert operator in control at all times, and have automatic brakes (dead-man switches) to prevent roll away accidents.

I pray that you listen to us people and preserve commonsense actions and keep us safe. This oil proposal plus the coal transport are dangerous and foolhardy proposals. We need to be decreasing fossil fuel use AND why are they sending

all this coal and oil overseas if it's so important? Why doesn't it get used in USA? Answer this. WE DO NOT NEED MORE FOSSIL FUEL POLLUTION, IN USA OR ANYWHERE IN THE WORLD.
