Notice of Public Meeting and Opportunity for Public Comment

Technical Amendment to Site Certification Agreement for Grays Harbor Energy, LLC Electrical Generating Facility Elma, WA

What projects are proposed?

Grays Harbor Energy Center (GHEC) Site Certification Agreement Technical Amendment

The Energy Facility Site Evaluation Council (EFSEC) received an amendment request proposing a technical amendment to the current GHEC Site Certification Agreement (SCA). This request would amend the SCA to reflect proposed changes to GHEC. The proposed changes include the installation of General Electric's Advanced Gas Path (AGP) package in the combustion turbines in Units 1 and 2 and an extension for the start of construction for Units 3 and 4.

The proposed revisions will change the following in the current SCA:

- Increase combustion turbine output to 181.2 MW from the current 175 MW.
- Extend the start of construction date for Units 3 and 4 to be no later than February 18, 2028. This is an extension from a previous date of 10 years from execution of Amendment 5, February 18, 2021.

What is EFSEC is proposing to do?

EFSEC is proposing to hold a public meeting, at which GHEC will present their amendment request. The public will then have an opportunity to provide comment on the request for the Council's consideration.
