- 5 MR. DENGEL: Rob Dengel, motion to approve
- 6 the March 30, 2021 Horse Heaven Wind Project
- 7 informational meeting minutes.
- 8 CHAIR DREW: Thank you.
- 9 Second?
- MS. KELLY: Kate Kelly, second.
- 11 CHAIR DREW: Thank you.
- 12 Are there any corrections or discussion
- 13 about the minutes from the informational meeting?
- 14 Hearing none, all those in favor of approving --
- 15 approving the informational meeting minutes for Horse
- 16 Heaven Hills Wind Project March 30, 2021, please say
- 17 "aye."
- 18 COUNCILMEMBERS: Aye.
- 19 CHAIR DREW: Opposed? The meetings are
- 20 approved.
- 21 Moving on to the land use consistency
- 22 hearing Scout Clean Energy Horse Heaven Hills Wind
- 23 Project March 30, 2021 minutes, is there a motion to
- 24 approve the minutes?
- MR. BROST: Ed Brost, I'll move to approve.

Page 8 CHAIR DREW: Thank you. 1 2. THE COURT REPORTER: I'm sorry, this is the 3 court reporter. I didn't hear that. CHAIR DREW: I believe that was Mr. Brost? 4 5 MR. BROST: Yes. 6 THE COURT REPORTER: Thank you. CHAIR DREW: Is there a second? 8 MR. DENGEL: Motion to second. 9 CHAIR DREW: Thank you, Mr. Dengel. 10 Is there any -- are there any corrections or changes to the minutes for the land use consistency 11 12 hearing from March 30, 2021? Hearing none, all those in favor of approving the minutes from the land use 13 consistency hearing, please say "aye." 14 15 COUNCILMEMBERS: Aye. 16 CHAIR DREW: All those opposed? Minutes are 17 approved. Moving on to the monthly Council meeting 18 19 minutes from April 20th, 2021. Is there a motion to approve the monthly -- April monthly Council meeting 20 21 minutes? 22 MR. DENGEL: Rob Dengel, motion to approve April 20th monthly meeting minutes. 23 CHAIR DREW: 24 Thank you. 25 Second?

- 1 MS. BREWSTER: Stacey Brewster, second.
- 2 CHAIR DREW: Thank you.
- I do have one correction in the Council
- 4 minutes and that is page 14, line 5. It says wind lands
- 5 and it should be wetlands.
- 6 Are there other corrections? Hearing
- 7 none --
- 8 MR. KOBUS: Chair Drew, if I could just for
- 9 a moment. This is Dave Kobus with Scout Clean Energy.
- 10 CHAIR DREW: Yes?
- MR. KOBUS: Regarding the Horse Heaven Wind
- 12 Project, I would suggest that the title be changed to
- delete hills as hills is not really part of the official
- 14 name of the project.
- 15 CHAIR DREW: Okay. And was that in the
- 16 previous -- where --
- 17 MR. KOBUS: Yeah, that was -- that was in
- 18 two previous documents. I just realized that. You were
- 19 saying hills and it's -- it's not part of the actual
- 20 name of the project.
- 21 CHAIR DREW: Is that -- I'm sorry, I said it
- 22 as that -- as it was written. I don't have it in front
- 23 of me anymore. Let's see.
- 24 Maybe you can help me out with this,
- 25 Ms. Owens.

- 1 MS. OWENS: The land use minutes should be
- 2 on the screen now. Can you see them?
- 3 CHAIR DREW: Oh, okay. Is it also the same
- 4 as -- in the --
- 5 MS. OWENS: It is.
- 6 CHAIR DREW: Okay. May I have a motion to
- 7 then go back and change the title of the informational
- 8 meeting and the land use consistency hearing meeting
- 9 titles to eliminate the word "hills" in the title and
- 10 throughout -- I think it's probably just the title -- as
- 11 it appears throughout the document?
- 12 MR. BROST: As long as it's just the title,
- 13 this is Ed Brost, I'll motion to approve.
- 14 CHAIR DREW: Okay. Thank you.
- 15 Is there a second?
- MS. KELLY: Kate Kelly, second.
- 17 CHAIR DREW: Okay. All those in favor of
- 18 deleting the word "hills" from the title on the
- 19 informational meeting minutes and in the land use
- 20 consistency hearing minutes, all those in favor?
- 21 COUNCILMEMBERS: Aye.
- 22 CHAIR DREW: Opposed? Thank you.
- Okay. Let's take a step back. We were in
- 24 the middle of the approval of the Council meeting
- 25 minutes. I apologize. I guess there was a motion on

- 1 the floor before I went to make that change. The April
- 2 monthly meeting minutes with one change as previously
- 3 stated on page 14, line 5, should be wetlands rather
- 4 than wind lands. With that amendment, all those in
- 5 favor of approving the minutes from the April 20th, 2021
- 6 Council meeting, please say "aye."
- 7 COUNCILMEMBERS: Aye.
- 8 CHAIR DREW: Opposed? The minutes are
- 9 approved.
- 10 Okay. Thank you, everybody. That was a lot
- 11 to review and to move forward on. So now moving to our
- 12 project updates. Kittitas Valley Wind Project, is
- 13 Mr. Melbardis here?
- MR. MELBARDIS: Yes, I am.
- 15 CHAIR DREW: Thank you.
- 16 MR. MELBARDIS: Good afternoon, Chair Drew,
- 17 EFSEC Council, and Staff. For the record, this is Eric
- 18 Melbardis with EDP Renewables with the Kittitas Valley
- 19 Wind Power Project. We had nothing nonroutine to report
- 20 for the period.
- 21 CHAIR DREW: Thank you.
- 22 Moving on to the Wild Horse Wind Power
- 23 Project, Ms. Galbraith?
- 24 MS. GALBRAITH: Yes, thank you, Chair Drew,
- 25 Councilmembers, and Staff. This is Jennifer Galbraith

- 1 with Puget Sound Energy representing the Wild Horse Wind
- 2 Facility, and I have nothing nonroutine to report for
- 3 the month of April.
- 4 CHAIR DREW: Thank you.
- 5 Chehalis Generation Facility, Mr. Miller?
- 6 MR. MILLER: Good afternoon, Chair Drew,
- 7 EFSEC Council, and Staff. This is Mark Miller, the
- 8 plant manager representing the PacifiCorp Chehalis
- 9 Generation Facility. I have one nonroutine note in the
- 10 submitted report for the month of April.
- 11 The Chehalis plant conducted an annual
- 12 relative accuracy test audit of the continuous emission
- 13 monitors during the last week of April. The preliminary
- 14 results were within compliance requirements, and a draft
- 15 report is currently being reviewed by PacifiCorp
- 16 corporate environmental staff and it will be submitted
- 17 to EFSEC Staff this month, the month of May.
- 18 CHAIR DREW: Thank you.
- 19 Grays Harbor Energy Center, Mr. Sherin?
- 20 MR. SHERIN: Good afternoon -- good
- 21 afternoon, Chair Drew, Councilmembers, and Staff. This
- 22 is -- this is Chris Sherin, plant manager with Grays
- 23 Harbor Energy Center. Nonroutine items for the month of
- 24 April, I'll point out that we did begin our annual
- 25 maintenance outage on April 15th conducting major

- 1 inspections on the gas turbine, the (unintelligible)
- 2 turbine, and also the -- we're undergoing the
- 3 implementation of the installation of the AGP on -- on
- 4 the gas turbines.
- 5 Under environment compliance, one -- I need
- 6 to make one correction on the first bullet. I need to
- 7 remove the word "emission," because as I'll point out in
- 8 nonroutine -- for nonroutine items, Grays Harbor
- 9 submitted a letter notifying EFSEC Staff of an emissions
- 10 event on April 8th. The event was a technical violation
- 11 of the Air Operating Permit, but no environmental limits
- 12 were exceeded. So we're currently working with ORCAA
- 13 and EFSEC Staff to tell us what the next step with the
- 14 event is.
- 15 Also for nonroutine items, I'll point out
- 16 that we're in the process of updating our CO2 mitigation
- 17 planned annual payments for the site certification
- 18 amendment agreement. Because due to the installation of
- 19 AGP, it necessitated a change to the annual payments
- 20 that we make to the Climate Trust, and that plan has
- 21 been submitted to EFSEC Staff.
- That's all I have unless there's any
- 23 questions.
- 24 CHAIR DREW: Thank you.
- 25 Are there any questions?

- I don't hear any. Thank you, Mr. Sherin.
- 2 Moving on to the Columbia Generating Station
- 3 and WNP-1/4, Ms. Ramos.
- 4 MS. RAMOS: Good afternoon, Chair Drew,
- 5 EFSEC Councilmembers, and Staff. This is Mary Ramos
- 6 reporting for Energy Northwest. For the month of April,
- 7 I have two items to report.
- 8 The first one is Energy Northwest requested
- 9 and received approval to operate on nonroad engines with
- 10 a cumulative size greater than 2,000 horsepower on site.
- 11 And the nonroad engines are being utilized to support
- 12 Columbia's R-25 refueling and maintenance outage.
- 13 The second item I have to report is the
- 14 Amendment 1 for EFSEC Resolution 347 was issued on April
- 15 23. This resolution authorizes fish -- fish collection
- 16 for the Columbia Generating Station Radiological
- 17 Environmental Monitoring Program.
- That's all I have.
- 19 CHAIR DREW: Thank you.
- 20 Are there any questions?
- 21 Hearing none, we will be moving on to the
- 22 Desert Claim Wind Power Project. Ms. Moon?
- MS. MOON: Good afternoon, Council Chair
- 24 Drew and Councilmembers. For the record, this is Amy
- 25 Moon providing an update on the Desert Claim Project.

- 1 EFSEC Staff continue to coordinate with Desert Claim;
- 2 however, currently there are no other project updates.
- 3 CHAIR DREW: Okay. Thank you.
- 4 Moving on to the Columbia Solar Project.
- 5 Mr. Overton.
- 6 MR. OVERTON: Yes, this is Kyle Overton, the
- 7 EFSEC site specialist overseeing the Columbia Solar
- 8 Project. I have two items today for Columbia Solar.
- 9 The first being that EFSEC Staff, we
- 10 continue to coordinate with the facility and our
- 11 contractors on preconstruction plan review. This
- 12 includes review and coordination on the initial site
- 13 restoration plan, or the ISRP, as required by Washington
- 14 Administrative Code or WAC 463-72-040 and their site
- 15 certification agreements. EFSEC Staff are working with
- 16 the certificate holder to finalize these ISRPs and after
- 17 which they will be presented to the Council for their
- 18 approval.
- 19 Is there any questions on that part?
- 20 CHAIR DREW: My question would be, you were
- 21 working on that now, do you expect that you will have it
- 22 to the Council before the June meeting so that
- 23 Councilmembers can review it and then we'll have an
- 24 opportunity to discuss it at the June meeting?
- 25 MR. OVERTON: That's our goal. We're --

- 1 we're very close to getting a final product. There's
- 2 just a few items to work out. So that's our current
- 3 goal, yes, have it ready for June 15th meeting.
- 4 CHAIR DREW: Okay. Thank you.
- 5 Any other questions?
- 6 Okay. Go ahead.
- 7 MR. OVERTON: All right. So my next item
- 8 here, you know, Staff are also continuing to work with
- 9 the certificate holder on issuing permits required prior
- 10 to construction. I noticed intent for each of the three
- 11 facilities to be covered under general construction
- 12 stormwater permits for the three sites were submitted by
- 13 the certificate holder on April 28th.
- 14 In accordance with WAC 463-76-041, a 30-day
- 15 public comment period is required prior to issuing these
- 16 permits. The public comment period is scheduled to
- 17 start on May 19th and will continue on June -- or
- 18 conclude on June 18th. Notice has been distributed to
- 19 our mailing lists and posted in the Daily Record paper
- 20 in Ellensburg, Washington. Comments will be accepted in
- 21 writing via email and via our online comment database,
- 22 which can be found on the EFSEC website.
- 23 Are there any questions for that?
- 24 CHAIR DREW: Are there any questions from
- 25 Councilmembers?

- I don't see anyone raising questions. Thank
- 2 you.
- 3 MR. OVERTON: Yep, thank you.
- 4 CHAIR DREW: Oh, Goose Prairie Solar
- 5 Project, Mr. Overton.
- 6 MR. OVERTON: Yeah, this is Kyle Overton
- 7 again, the EFSEC site specialist for Goose Prairie. Two
- 8 items here also.
- 9 The Staff continue to coordinate with the
- 10 applicant and our contractors on review of their
- 11 application materials, and a site visit was conducted on
- 12 May 4th with representatives from One Energy, Department
- of Ecology, and WFW present. The purpose of the site
- 14 visit was to conduct the wetland screening and to aid
- 15 the ongoing wildlife and habitat impact review for the
- 16 State Environmental Policy Act or SEPA. That was a
- 17 general update on the current status of the project
- 18 there.
- The next item, WAC 463-43-050 requires that
- 20 a SEPA determination is needed prior to making a
- 21 decision regarding the applicant's request for expedited
- 22 processing. WAC 463-43-050 also requires a decision on
- 23 expedited processing 120 days after receipt of their
- 24 request or such time later as is mutually agreed by the
- 25 applicants and Council.

- 1 EFSEC received the request for expedited
- 2 processing on January 21st making May 21st the 120-day
- 3 mark. On May 14th, EFSEC received requests from One
- 4 Energy with the support of EFSEC Staff to extend the
- 5 expedited processing determination deadline to the
- 6 completion of the SEPA review and issuance of
- 7 determination. One Energy is requesting the deadline be
- 8 extended to the date of the July Council meeting and a
- 9 copy of this request letter is included in the Council
- 10 packets.
- 11 Are there any questions?
- 12 CHAIR DREW: Are there any questions from
- 13 Councilmembers?
- MS. MOON: Chair Drew?
- 15 CHAIR DREW: Yes?
- MS. MOON: This is Amy Moon. I had to step
- 17 away real quick. So did I miss my Horse Heaven Wind
- 18 Project update?
- 19 CHAIR DREW: No, we're still on Goose
- 20 Prairie.
- 21 MS. MOON: Great. Thank you.
- 22 CHAIR DREW: So there before you on the
- 23 screen is the letter from One Energy requesting the
- 24 extension. As I understand it, this doesn't require
- 25 Council action since this is agreed to both by the

- 1 applicant and by our Staff, but that is for your
- 2 information, that 120 days, the consideration for
- 3 expedited processing will be extended to July 15th. Any
- 4 questions from Councilmembers?
- 5 MS. KIDDER: Chair Drew, if I could --
- 6 CHAIR DREW: Yes, Ms. Kidder?
- 7 MS. KIDDER: -- make a quick comment. This
- 8 is Ami Kidder for the record. The language in WAC
- 9 463-43-050 does say within 120 days of receipt of
- 10 application or such time -- such later time as is
- 11 mutually agreed upon by the applicant and the Council.
- 12 As previously mentioned, Staff does recommend agreement
- 13 with this request, and previously the Council has taken
- 14 votes on this request, although it is not explicitly
- 15 required to be voted on. But we would like to make sure
- 16 that the Council has no concerns with approving this.
- 17 CHAIR DREW: Thank you, Ms. Kidder.
- 18 Are there any concerns with approving this
- 19 extension?
- 20 Okay. Sounds like this is agreed upon by
- 21 the Council since we have no -- no disagreements on
- 22 that.
- MS. KIDDER: Thank you, Chair Drew.
- 24 CHAIR DREW: Moving on to the Horse Heaven
- 25 Wind Project, Ms. Moon.

- 1 MS. MOON: Okay. Thank you, Chair Drew.
- 2 Good afternoon, Council Chair Drew and Councilmembers.
- 3 For the record, this is Amy Moon providing an update on
- 4 Horse Heaven Wind Project. EFSEC issued a State
- 5 Environmental Policy Act, otherwise known as SEPA,
- 6 determination of significance and request for comments
- 7 of scope of environmental impact statement, which is an
- 8 EIS, for the Horse Heaven Wind Project on May 11th. The
- 9 notice stated that an EIS will be prepared and
- 10 identified wildlife habitat, visual aesthetics, and land
- 11 use as environmental elements that require a detailed
- 12 analysis.
- In addition, the notice stated that
- 14 additional information is required before the -- before
- 15 determining the level of analysis in the EIS for air,
- 16 water, and water includes wetlands, water quality, and
- 17 water resources, plants, energy and natural resources,
- 18 environmental health, noise, light and glare, historical
- 19 resources, and cultural resources.
- 20 The EIS will at a minimum include a no
- 21 action alternative and the applicant's proposal. EFSEC
- 22 will determine the full scope of the EIS including the
- 23 range of alternatives to be analyzed at the end of the
- 24 scoping period after comments are reviewed. A public
- 25 comment period for the scoping is open until June 10th,

- 1 which allows for a 30-day comment period from the date
- 2 of posting, which was May 11th.
- And on May 10th, EFSEC Staff, an Ecology
- 4 wetland scientist, and the applicant met at the project
- 5 site for a wetland site visit. We visited several
- 6 locations that had been identified during a desktop
- 7 published resource review as potential wetlands and no
- 8 wetlands were found.
- 9 Does the Council have any questions?
- 10 CHAIR DREW: So, again, the scoping notice
- 11 has been sent to everyone on our list and is also on our
- 12 website if people would like to take a look at that and
- 13 how to respond; is that correct?
- MS. MOON: Correct.
- 15 CHAIR DREW: Okay. Are there questions from
- 16 Councilmembers?
- 17 Okay. I don't hear any. Thank you. We
- 18 look forward to information following this scoping
- 19 period.
- 20 And at this point, that concludes our
- 21 agenda. So this meeting is adjourned and our next
- 22 meeting will be -- and of course I did not put the date
- 23 in front of me -- third Tuesday of June. We will talk
- 24 to you all and expect additional information
- 25 particularly on the Columbia Solar Project at a minimum
