<b>Background:</b>	<ul style="list-style-type: none"> <li>• With the Clean Energy Transformation Act (CETA) of 2019, Washington set course to rapidly increase the generation of carbon-free energy from renewable sources.</li> </ul>	
<b>Purpose:</b> (CETA, Sec. 25)	<ul style="list-style-type: none"> <li>• “The legislature finds that based on current technology, there will likely need to be upgrades to electricity transmission and distribution infrastructure across the state to meet the goals specified in this act.”</li> <li>• “These facilities require a significant planning horizon to deliver electricity generation sites to retail electric load.”</li> </ul>	
<b>Objectives:</b> (CETA, Sec. 25)	<p><b>The EFSEC chair shall:</b></p> <ul style="list-style-type: none"> <li>• <b>Convene</b> a transmission corridors work group and</li> <li>• <b>Report its findings</b> to the governor and legislative committees by December 31, 2022.</li> </ul> <p><b>The work group shall:</b></p> <ol style="list-style-type: none"> <li>1. <b>Review the need for upgraded and new electricity transmission and distribution facilities</b> to improve reliability, relieve congestion, and enhance the capability of the transmission and distribution facilities in the state to deliver electricity from electric generation, non-emitting electric generation, or renewable resources to retail electric load;</li> <li>2. <b>Identify areas where transmission and distribution facilities may need to be enhanced or constructed;</b> and</li> <li>3. <b>Identify environmental review options that may be required</b> to complete the designation of such corridors <b>and recommend ways to expedite review</b> of transmission projects without compromising required environmental protection.</li> </ol>
