2. Preliminary Order on Intervention

The petitions filed by the Yakama Nation and by Tri-Cities C.A.R.E.S. were both **GRANTED** IAW WAC 463-30-092 per Judge Torem's Preliminary Order on Intervention, with a reservation that the exact scope of intervention would be determined at a later date, following PHC #1.
