10 Tri-Cities C.A.R.E.S (TCC) moves the Presiding Administrative Law Judge  
11 (PALJ) to issue an order allowing the record to be supplemented with the deposition of  
12 Mr David Kobus taken on July 21, 2023.

13 Mr. Kobus is the Project Manager for Scout Clean Energy (SCE) and is identified  
14 in the Updated Application for Site Certification (UASC) as the agent for SCE. The  
15 taking of Mr. Kobus' deposition was specifically permitted by an order of the PALJ. All  
16 parties were given due notice of the deposition and all parties were given the  
17 opportunity to ask Mr. Kobus questions during the deposition.

18 It is appropriate that Mr. Kobus's deposition be made a part of the record as the  
19 UASC does not have a sponsoring witness and he is the principal agent and project  
20 manager of SCE.

21 The PALJ should grant an order allowing the Kobus deposition to be made a part  
22 of the record.
