I found that the silicon smelting process is NOT included in silicon solar panel carbon footprints, and that the LCI/LCA process for determining carbon footprints is highly subjective, and gives inconsistent and non-comparable results. I am very concerned about climate change, but what I have found regarding silicon solar panels and carbon footprint calculations tells me that there is corruption in some alternative energy claims; and until this is fixed, we will continue to exacerbate the impacts of climate change.
