Q: Please describe your opinion on the effect this project will have on the property value of your home, your farm, and other farms in the area.

A: The photo of the map location of my house at page 3, provided to me by Tri-City Cares member Paul Krupin, indicates that my house will be surrounded by turbines to the south from west to east. They will be very close – one to two miles. The wind towers are an eyesore to look at. They make a humming sound on high wind days and endangered birds are at risk along with migrating flocks of being killed from the blades. The wind turbines and 100 miles of unpaved gravel and dirt access roads will divide up the fields making it harder to farm. The wind blows frequently here and this will make it significantly more dusty than it already is. It will make the air quality worse than ever before. There is research that shows the turbines increase the evaporation of water from the ground, decreasing moisture for the dry land farmer. We are zoned agriculture so how can they put industrial wind towers out here in the first place? Lease payments from the towers aren't worth all the negative things. There would be no aerial applications of fertilizer with the wind turbines in the way.



Cal-Topo terrain map showing the location of the Miller house at 54737 S C. Williams Road, Kennewick WA 99338




