WHEREAS, the Wallula Gap Solar Project applied for site certification with the Washington State Energy Facility Site Evaluation Council (Council) on February 23, 2024; and

WHEREAS, the Wallula Gap Project is a solar energy generation facility proposed to be located in unincorporated Benton County; and

WHEREAS, RCW 80.50.030 (4) provides Benton County the opportunity to appoint a member or designee as a voting member to the Council; and


WHEREAS, the appointee will sit with the Council only at such times the Council considers the proposed Wallula Gap Solar Project; and

WHEREAS, the appointee will serve on the Council until there has been a final acceptance or rejection of the proposed Wallula Gap Solar Project; and



Dear Commissioners:

On February 23, 2024, the Washington State Energy Facility Site Evaluation Council (EFSEC) received an Application for Site Certification (ASC) from Wallula Gap Solar, LLC for a 60-megawatt (MW) solar photovoltaic (PV) generation facility with optional battery storage located in unincorporated Benton County, Washington.

This application starts EFSEC's process for review as authorized under Title 80.50 RCW in accordance with its rules codified in Chapter 463 WAC. State law provides:

“The appropriate county legislative authority of every county wherein an application for a proposed site is filed shall appoint a member or designee as a voting member to the council. The member or designee so appointed shall sit with the council only at such times as the council considers the proposed site for the county which he or she represents, and such member or designee shall serve until there has been a final acceptance or rejection of the proposed site.” [RCW 80.50.030(4)].

The person the Board of Benton County Commissioners appoints as a voting member of EFSEC should be familiar with county issues to provide local insight to the EFSEC process. We respectfully request that the appointment of the Benton County EFSEC representative be made no later than April 23rd, 2024.

EFSEC may hold adjudicative proceedings for these projects, so the person you appoint will need to become aware of *ex parte* rules and regulations that apply to each EFSEC Council member. In addition, the person must be able to participate fully in EFSEC's process. EFSEC expects the time commitment to initially be approximately one day per month starting in April 2024. The time commitment will increase if an adjudicative proceeding is held.

RCW 80.50.090 requires EFSEC to hold a public information meeting within sixty days of receipt of an application. More information will follow once the meeting details are available.

Subsequent to the informational meeting EFSEC will conduct a land use hearing. A notice will be sent to you when it is scheduled and to the project email list. If you would like to continue to receive
